 Construction & Demolition Rules



Transfer Facility Information:

Location: The Trash Transfer Station is located at Horsethief Canyon, about 5 miles south of High School Road on the east side of South Highway 89.

Hours of Operation:

Monday - Friday:

Summer (mid-May – mid-October) **7 a.m. - 3 p.m.**

Winter (mid-October – mid-May) **8 a.m. – 3 p.m.**

Saturday: (year 'round) **9 a.m. – 1 p.m.**

When you receive a permit for construction or demolition, you are required to contact the TTS Scale House or ISWR Office with your disposal plans. Please give 48 hours notice.

Please sort your loads according to the chart below. A tip fee of \$200 per ton (includes sort fee) will be assessed if waste is not properly sorted. Personnel will direct you to the proper location. Please tarp and tie down all loads – there are additional fees for non-compliance.

Material	Disposal Site	Tip Fee
Concrete/Asphalt/Masonry Block	Concrete pile	\$70 per ton
Construction/Demolition Debris/Trash	Transfer Station tip floor	\$110 per ton
Dimensional Wood	Upper hill, wood pile	\$70 per ton
Non-Certified Refrigeration Units	Transfer Station tip floor	\$35 per ton, plus \$35 per unit for Freon removal
Scrap Metal/Wire/Metal Fencing/Appliances	Scrap metal pile	\$35 per ton
Trees/Branches/Weeds/Grass/Shrubs	Upper hill, compost pile	\$70 per ton

The following materials are ***banned*** from the Trash Transfer Station.

Asbestos

- For friable asbestos removal, call Dave Price, (208) 681-6462.
- For non-friable asbestos removal, call Doug Schupman, (307) 733-6840.

Compact Fluorescent Bulbs and Tubes – Please make an appointment to dispose of them at the HHW facility, April – October only, 733-7678. Cost is 60 cents per bulb/tube.

Electronics – Bring electronics to the Recycling Center for disposal, Monday – Friday, 9am-6pm. Cost is 40 cents/pound.

Liquid Waste - Sewage sludge, cooking oil

Specific construction/demolition material disposal information:

Construction/Demolition Debris - includes non-wood roofing materials; insulation; drywall/gypsum board; carpeting and pads; tile with grout/mesh attached; toilets; ceramic sinks; shower stalls, etc.

- Materials must be smashed to the smallest possible size in order to ensure safe loading onto the tip floor.
- Absolutely no metal, wood, rock, or concrete is allowed on the tipping floor.

Concrete/Asphalt/Masonry Block/Stone/Brick/Clean Tile

- Concrete slabs should weigh **no more than 300 lb.** (approx. 2'X2' slabs).
- Concrete with mesh or rebar – steel posts or rebar must be cut flush with concrete slabs.

Dimensional Wood– It is extremely important to bring in “clean” dimensional wood; it is chipped and used for heating fuel. If wood can't be cleaned of unacceptable materials, please cut it into 3-foot pieces and bring it to the tip floor.

Unacceptable:

- Metal attached that is larger than nails, screws or staples. You may leave hinges or brackets that are no more than 1/8 inch thick on the lumber.
- Insulation
- Tar paper – even small pieces
- Electrical wiring
- Styrofoam
- Cardboard
- Drywall or gypsum board
- Windows or glass
- Entire truss structures - If you bring truss sections or railroad ties, cut the wood as close to the metal angle irons as possible, and cut it in 3-foot sections.
- ***Absolutely no trash!***

Fuel Storage Tanks – Regardless of size, fuel storage tanks have to be certified decommissioned before they can be disposed of at the transfer station with scrap metal. Leonard Petroleum, Idaho Falls certifies them; call Joe at (208) 522-7547; or Gene Robinson, Casper, certifies them, (307) 234-4803 or (307) 267-0766.

Metal/Wire

- All appliances except non-certified refrigeration units
- Aluminum framed doors and windows (**glass removed**)
- Electrical wires and conduit
- Metal fencing
- Plumbing fixtures

Refrigeration Units – Non-certified units go to the transfer building for Freon removal.

Trees/Branches

- Stumps must be free of rocks and dirt.
- Stumps over 25" in diameter must be cut into 3-foot sections.
